## LICENSE FEE: \$200.00 ANNUALLY

**ALL Applicants shall be required to pay a public hearing notice fee of \$50.00, in addition to the license fee.**

To be considered for a license, all applications must include the following (*Failure to supply required documents will stop any application process*):

- A copy of the applicant's state license application and supporting documentation as filed with the State of Maine Office of Marijuana Policy.
- Evidence of all state approvals or Conditional License required to operate an Adult Use or Medical Marijuana Establishment
- Attested copies of the Articles of Incorporation and Bylaws, if the applicant is a corporation, or Operating Agreement if the applicant is a LLC, or evidence of partnership, or Articles of Association and Bylaws if the applicant is an association.
- Affidavit that identifies all owners, officer, members, managers or partners of the applicant, their ownership interests and their places of residence at the time of the application and for the immediately preceding three (3) years.
- A description of the premises for which the license is sought, including a plan/layout of the premises.
- Payment made out to the Town of Brownville for \$250.00 (\$200 for License, \$50 for public hearing notice)
